### CALL FOR PAPERS

The International Symposia on Classical German Philosophy were initiated by the German/Latin-American Research and Doctoral Network in Philosophy (FILORED), a cooperative network of the FernUniversität in Hagen (Germany), the Ruhr-Universität Bochum (Germany), the Martin-Luther-Universität Halle-Wittenberg (Germany), the Pontificia Universidad Católica Argentina (Argentina), the Universidad Diego Portales (Chile), the Pontificia Universidad Católica de Valparaíso (Chile), the Universidad Federal do Ceará (Brazil), the Pontificia Universidad Católica do Rio Grande do Sul (Brazil), the Universidade Federal de São Carlos (Brazil), the Universidad Nacional de Colombia (Colombia), the Universidad Autónoma Metropolitana (Mexico) and the Pontificia Universidad Católica del Perú (Peru). In addition to these universities, there are also two Research Groups officially associated with FILORED, namely the Grupo de Estudios Kantianos of the Universidad de Buenos Aires (Argentina) and the Centro de Estudios de Filosofía Clásica Alemana of the Universidad Nacional de Cuyo (Argentina).

#### Main Themes and Sections:

- Sources and historical aspects of the epistemology of Kant and the post-Kantian idealists.
- The realism-idealism debate in 18th and 19th Century German philosophy.
- Idealist theories of feeling, perception, imagination and conceptual thought.
- Knowledge, self-determination and freedom in German idealism.
- Practical reason and political order from Kant to Hegel.
- Later critiques and appropriations of Kant's and post-Kantian idealists' epistemologies.

#### Submission requirements:

1. Proposals may be submitted in Spanish, Portuguese, German or English.
2. The author's name, paper title, institutional position and affiliation, contact information as well as a short CV (200-300 words) should be included in the body of the e-mail.
3. Abstracts should contain 500-700 words and be prepared for blind review by removing any identifying details. (Presentation time should be no more than 30 minutes, plus 10 minutes for discussion).
4. **New deadline for submissions: August 21, 2022** (Notification of acceptance or rejection will be given separately approximately two weeks following receipt of each submission.)
5. There will be no registration fee.
